Specializing in large-scale cross-border litigation and arbitration. Representing a property developer in Beijing Chao Yang District (now called the “No. 9 Gardens”) for over seven years in HCA 1216 of 2002 and CACV 347 of 2006.

Specializing in civil litigation and arbitration; applying for world-wide Mareva Injunctions and receivership order, committal order and judicial review, handling negligence claims, personal injury and defamation claims.

The trial of the case lasted for half a year and all the Defendants were acquitted by an unanimous verdict delivered by the Jury.

The Siu Fung Ceramics Holdings Ltd.
