Niklaus Zaugg graduated from the Universities of Geneva and Zurich in 2003. In 2006, he was admitted to the bar and passed the Concours Diplomatique of the Swiss Foreign Ministry. He further holds an LL.M. degree from the University of Sydney Law School, obtained in 2011. In 2014, Niklaus Zaugg's doctoral thesis was approved by the University of Lucerne.

Before joining CMS and working as an attorney, Niklaus Zaugg has worked as a law clerk and chairman of the conciliation authority dealing with lease and rental matters at the District Court of Zurich. He has further been a diplomatic attaché at the Political and Legal Affairs' Section of the Swiss Embassy in Washington, D.C. and has acted as the executive secretary of the Center for Conflict Resolution CCR at the Faculty of Law at University of Lucerne.
